**INVITATION TO PURCHASE 51% INTEREST IN THE ASSETS OF THE  
DODOMA ABATTOIR**

1. The Government of the United of Tanzania through the Ministry of Livestock Development invites private investors to purchase 51% interest in the assets of Dodoma Abattoir and incorporate a joint venture company with National Ranching Company (**NARCO**) to operate the business of the Dodoma Abattoir.
2. The assets comprise a newly constructed modern abattoir building, an office block and land, located at Zuzu in the municipality of Dodoma, the capital of Tanzania. Dodoma Abattoir is located 5 kilometers at the Western industrial area on plots 113-125. The area inclosing the plots covers 11 hectares. The Main Abattoir Building has overall dimension of approximately 55 meters by 13.8 meters and provides lean –to office and lobby on the rear side and lean-to –workshop, plant –room, on the far side. The total floor area is 863 square meters. The main structure is made of reinforced masonry exterior walls; the roofing being of steel trusses clad with specially galvanized corrugated iron sheets. The interior is insulated so as to conserve centrally controlled air conditioning.
3. The capacity of Dodoma Abattoir is to slaughter 200 cattle and 200 shoats per day in the two shifts of eight hours.

The 51% interest in the assets is being sold as a package.

4. Interested eligible bidders may obtain further information from and inspect the Bidding Documents at the office of the Secretary, Ministerial Tender Board, Mifugo Veterinary- Temeke, along Mandela Road, Ministry of Livestock Development, P O Box 9152, Dar es Salaam from 7.30 am to 3.30 pm on Mondays to Fridays inclusive except on public holidays.

5. A complete set of Bidding Document(s) and additional sets may be purchased by any interested bidders on the submission of a written application to the address given in paragraph 4 above and upon payment of a non-refundable fee of US\$ 100 (United States Dollars One Hundred only or equivalent in Tanzania Shillings. Payment should either be by Cash, Banker's Draft, or Banker's Cheque payable to the Permanent secretary, Ministry of Livestock Development, P O Box 9152, Dar es Salaam.

**Note** that, the purchase of Bid Documents is **Mandatory** as it contains all the bidding instructions. An original receipt issued on the purchase of the bidding document must be included in the submitted bid otherwise it may be disqualified.

6. All bids in one original plus two copies, properly filled in and enclosed in plain envelopes must be accompanied by an Original Bid Bond in a format attached in the bid document with the amount of Ten Percent (10%) of the total bid value properly addressed to the Secretary, Ministerial Tender Board, Ministry of Livestock Development, P.O. Box 9152, Temeke Veterinary, Mifugo House, Dar es Salaam. Bid Securities must be addressed to the **Permanent Secretary, Ministry of Livestock Development, P.O. Box 9152, Dar es Salaam**. Bids may either be delivered by hand or be sent by registered post or sent by courier so as to reach the Secretary, Ministerial Tender Board, Ministry of Livestock Development, P.O. Box 9152, Temeke Veterinary, Mifugo House Dar es Salaam before the deadline for submission of bids. The Bid Bond must bear the name of the Permanent Secretary, Ministry of Livestock Development, P.O.Box 9152' Dar es Salaam and must be submitted together with the tender.
7. The deadline for the submission of bids is 10:00 hours local time on Friday 20<sup>th</sup> October 2006. Bids will be opened in public and in the presence of those bidder's representatives who choose to attend in the opening at the Conference Room of the Ministry of Livestock Development at Mifugo House Veterinary – Temeke. Bids sent by post must be registered. The outer cover shall be clearly marked "**TENDER NO.03 OF 2006/2007 FOR PURCHASE OF 51% INTEREST IN THE ASSETS OF DODOMA ABATTOIR, DO NOT OPEN BEFORE 10:00 HOURS LOCAL TIME ON Friday 20<sup>th</sup> October 2006**".
8. Telegraphic, Telex, Telefax and late non- Telegraphic, Telex and Telefax will not be accepted. Bids not received and not opened in public at the public bid opening exercise shall not be accepted for evaluation irrespective of the circumstances
