All tenders in one original plus two copies properly filled in, and enclosed in plain envelopes must be accompanied by an Original Bid Security in an acceptable form in the amount of 2.½% (two and one half Percent) of the total bid value properly addressed to the Secretary, Ministerial Tender Board, Mifugo Veterinary- Temeke, along Mandela Road, Ministry of Livestock Development, P.
